INFORMATION COLLECTION

Lions Reach Travel is the sole owner of the information collected on our websites (hereafter the “websites”). We collect information from Customers and visitors to the websites at different points on the websites.

PERSONALLY IDENTIFIABLE INFORMATION

Through your use of or visits to our websites, you may be required or requested to provide personally identifiable information to us. Personally identifiable information is any piece of information that can potentially be used to uniquely identify, contact, or locate a single person including names, addresses, email addresses, telephone numbers, passport numbers, and credit card or banking information.

CUSTOMER INFORMATION

A customer must provide biographical and contact information (such as name, mailing address, telephone numbers, and email address) to us. Customers are also required to provide payment information (such as credit card, debit card, or checking account information). We use this information to maintain contact with Customers and to process Customer purchase transactions.

PROFILE INFORMATION

Lions Reach Travel gathers and stores information that it collects through cookies, log files, clear gifs, and/or third parties to create a profile of visitors to our websites (“users”), including Customers. A profile is stored information that Lions Reach Travel keeps on individual users which details their viewing preferences. Profile information is tied to the user’s personally identifiable information to provide offers and improve the content of the site for the user.

INFORMATION USE & SHARING

PERSONALLY IDENTIFIABLE INFORMATION

Lions Reach Travel DOES NOT share personally identifiable information except with contracted service providers as may be necessary to: (a) process purchases and/or returns and obtain payment; (b) complete an enrollment as a Customer. We also provide information to third-party vendors to provide information on business metrics in the Activation, Booking and Sales Report sections.

ENROLLMENT INFORMATION

As a marketing company, Lions Reach Travel provides certain information to third-party vendors regarding Customers enrolled for business metrics purposes. If you enroll as a Customer of Lions Reach Travel, your name, address, email address, telephone number, services purchased, and sales volume information will be provided to the third-party vendors to whom this site is assigned as statistical information. No Billing Information or other personally identifiable information



will be shared with any other vendors, suppliers, third party providers, or advertisers, other than that required to process purchase transactions. Information relating to Customer is made available to vendors, suppliers, third party providers, or advertisers subject to a Confidentiality and Non-solicitation Covenant in the Agreement that each enters into with Lions Reach Travel. However, Lions Reach Travel does not warrant that other vendors, suppliers, third party providers, or advertisers will adhere to the confidentiality and non-solicitation covenants, and Lions Reach Travel shall not be responsible for any vendors', suppliers', third party providers', or advertisers' violation of these covenants.

SALES INFORMATION

If you make a purchase through this Site, we will provide the vendors, suppliers, third party providers, or advertisers to whom this Site is assigned with your name, contact information, a description of the item(s) purchased, and the sales volume associated with the purchase. No other personally identifiable information will be shared with the vendors, suppliers, third party providers, or advertisers.

AGGREGATE INFORMATION (NON-PERSONALLY IDENTIFIABLE)

Lions Reach Travel may share aggregated demographic information with our partners, vendors, suppliers, third party providers, and advertisers. This is not linked to any personally identifiable information.

BUSINESS TRANSITIONS

In the event Lions Reach Travel goes through a business transition, such as a merger, being acquired by another company, or selling a portion of its assets, the personal information of Customers will, in most instances, be part of the assets transferred. SPECIAL OFFERS AND UPDATES

SERVICE ANNOUNCEMENTS
